I warrant, agree, and represent I am not an employee, servant, or agent of Hawkeye Downs Speedway or the All Iowa Agricultural Association.

**OWNERSHIP:** If an owner of a registered car, I certify I have good and marketable title to said vehicle or any part thereof in the event the same is claimed pursuant to the rules.

**COMPLIANCE:** The undersigned hereby agrees to abide by all rules and regulations of Hawkeye Downs Speedway now published or hereafter amended. In consideration of the acceptance, the undersigned recognizes his/her obligations to the public and Hawkeye Downs Speedway agrees to compete in all possible events at Hawkeye Downs Speedway.

**The undersigned hereby agrees to abide by rules providing for confiscation of parts considered illegal, including "crate" engines.**

**FINANCIAL BENEFITS:** I agree on behalf of myself, my executors, heirs, and assigns that my maximum entitlement for injuries or death which are as a result of injuries or death sustained in Speedway events shall be limited to the benefits of the Competitor, Accident, Policy procured by Hawkeye Downs Speedway. The foregoing shall constitute the maximum limit of financial liability of the Speedway for any injuries (or death) occurring to me at any Speedway event.

**ADVERTISING RELEASE:** The undersigned consents to the use of his/her name, pictures of himself/herself, and his/her car for publicity, advertising, promotion, recording, or reporting and the reproduction of the same for sale and for endorsements before and after all events, and further consents to the publication or sale of the same in such manner as Hawkeye Downs deems appropriate without compensation to the undersigned.

**RELEASE:** The undersigned does hereby release, acquit, and forever discharge Hawkeye Downs Speedway, the All Iowa Agricultural Association, and all officers, directors, agents or employees of the same, all owners sponsors, or manufactures of any and all racing equipment on All Iowa's (Released party's) premises from any and all liability of any kind or character including all claims, cause of action, or possible causes of action, which may accrue to me, my heirs, next of kin, and/or personal representatives from every type of loss, damage, or injury (including death) that may be sustained by me or by my property while on, in, about, in route to, or exiting from All Iowa's premises. This Release is to be interpreted in the broadest form possible to release any and all potential claims of any kind against the Released Parties whether arising from racing activities or otherwise.

**FINAL DECISIONS:** By my signature below, I agree that any controversy or claim of any nature arising out of, or relating to, this Agreement, to racing activities; or the application of racing rules to race track related activities, will be decided solely by All Iowa Agricultural Association (Hawkeye Downs Speedway), and such decisions are final and binding and are not subject to further dispute, interpretation, or court action of any kind or character-the decision of All Iowa being final.

**ARBITRATION:** In the event of any dispute arising between the undersigned and All Iowa Agricultural Association (Hawkeye Downs Speedway), the parties hereto covenant, contract, and agree that such dispute must be resolved by binding arbitration on behalf of themselves, their heirs, next of kin, or personal representatives. By signing this registration, the undersigned acknowledges this contractual dispute resolution requirement and on behalf of himself/herself, their heirs, next of kin, and/or personal representatives understands, acknowledges, and agrees litigation in the courts of the State of Iowa or elsewhere is expressly prohibited as a result of this provision.
